PRIME LOCATION

Location

Built in 1870-72 by John Gibson for the National Provincial Bank, this stunning Grade II listed building sits in the prominent position on the corner of Mosley Street and Dean Street. The date of the banks establishment and the date of construction are inscribed around the top of the building.

In the late 18th century, the routes in the area became inadequate, and Mosley Street was built around 1784. Mosley Street was connected to a new road from the Quayside, Dean Street. The area became the main shopping and commercial district of the Georgian Town. Towards the end of the 19th century, Mosley Street was chosen as the location for regional branches of various banks, they built these extensive and beautiful buildings.
